A Resolution of Governance to Redefine the Powers and Responsibilities of the Vice President for Student Involvement, the Student Involvement board and its Members.

RG-FA-10-110

- Whereas:** The Vice President for Student Involvement is the main student liaison to student organizations; **AND**
- Whereas:** Student organizations need resources to strengthen their communication and prepare them for their presentations to the Student Involvement Board; **AND**
- Whereas:** The betterment of campus life depends on collaboration among student organizations; **AND**
- Whereas:** Article VI.C.3.D of the Constitution reads: “The Vice President for Student Involvement serves to address concerns on behalf of student organizations and related to student leadership. The Vice President for Student Involvement has the power and responsibility to:
- i. Chair the Student Involvement Board; and
 - ii. Appoint students to seats on the Student Involvement Board, subject to confirmation by the Executive Board. In addition to the applications of those nominated, the applications of all students for seats on the Student Involvement Board shall be forwarded to the Executive board.” **AND**
- Whereas:** Article II.G. 2 of the Bylaws reads: “Review is defined as oversight of the final decision of the appropriate committees for an approval or disapproval by the Student Involvement Board. The specific duties of the board are to:” **AND**
- Whereas:** Article II.G.3 of the Bylaws reads: “Members of the Student Involvement Board will have the responsibilities to:” **THEREFORE**

BE IT RESOLVED THAT:

Article VI.C.3.D of the Constitution be modified to read as follows:

The Vice President for Student Involvement serves to address concerns on behalf of student organizations and correlated to student leadership and to provide resources and opportunities to student organizations regarding collaboration and communication. The Vice President for Student Involvement has the power and responsibility to:

- i. Chair the Student Involvement Board
- ii. Appoint students to seats on the Student Involvement Board, subject to confirmation by the Executive Board. In addition to the applications of those nominated, the applications of all students for seats on the Student

Involvement Board shall be forwarded to the Executive Board. **AND FURTHER THAT**

Article II.G.2 of the Bylaws be modified to read as follows:

Review is defined as oversight of the final decision of the appropriate committees for an approval or disapproval by the Student Involvement Board. The specific duties of the board are to:

- i. Provide resources to student organizations regarding communication and collaboration. **AND FURTHER THAT**

Article II.G.3 of the Bylaws be modified to read as follows:

Members of the Student Involvement Board will have the responsibilities to:

- e. Meet with student organizations to prepare them for their meeting with the Student Involvement Board
